OLD GUYS SUMMER HOCKEY WAIVER AND RELEASE

The undersigned members of a group (hereinafter referred to as "Participants") wish to participate in Old Guys Summer Hockey (hereinafter referred to as "Hockey") to be conducted primarily at Wakota Civic Arena. Participants agree to allow Terrence Bogie (hereinafter referred to as "Bogie") to arrange ice times, collect fees, and to see that roughly one half of Participants form a team wearing white jerseys and the remaining Participants into a team wearing dark jerseys to compete in Hockey each session. It is understood and agreed by all parties that Bogie performs no other function than the aforementioned, nor is responsible for any other aspects or activities related to Hockey.

The undersigned further acknowledges and agrees:

- 1. That **Participants** are fully aware there are dangers and risks inherent to playing the sport of hockey in the **Hockey**, including, but not limited to, the possibility of physical injury while on the ice, while in the locker room, while anywhere on the ice arena premises, or any other causes; and
- 2. That Participants expressly assume all such dangers and risks relating to or arising out of participation in the Hockey; and
- 3. That **Participants** hereby forever release and discharge **Bogie** from and against any and all claims whatsoever, that **Participants** or their heirs, executors, administrators, successors or assigns have or hereafter, at any time, shall or may have against the **Bogie**, arising out of, or in connection with, participation in the **Hockey** whether or not arising out of negligence of **Bogie**, and agrees to assume all risk of and responsibility for personal injury or death to, or damage to or loss of property of, the undersigned understands and agrees that, in the event of any injury to the **Participant**, **Bogie** will not be responsible for any decisions relating to medical treatment for the **Participant** or for such treatment itself.

Miscellaneous

Participants also understand and agree that this release does not apply to any intentional, grossly negligent, willful or wanton acts on the part of any of the released parties. The Release shall be governed by and construed in accordance with the laws of the State of Minnesota, without reference to the conflict of law provisions thereof and Participants hereby consent to venue and personal jurisdiction in the district court of the State of Minnesota. If any portion of this Release shall be held invalid or unenforceable, the remaining portion hereof shall not be affected thereby and shall remain in full force and effect. Participants intend the statements made herein to be perpetual, and Participants will be bound by them unless and until expressly rescinded by the undersigned in writing and delivered via registered mail to Bogie.

Representations

The undersigned states that he/she read and understands the Release and that he/she has been given an opportunity to review this Release with anyone he/she chooses, including a lawyer, and has done so to the extent he/she wishes to do so. The undersigned further states that the **Participant** is in good physical condition, is physically fit to participate in the **Hockey** and is not subject to any medical condition that poses or may pose any risk of harm or disability to others.
